

Top 5 Venue Report of Bank Julius Baer Europe S.A.

In respect of orders received from Julius Baer Agencia de Valores S.A.U.

Reporting period: 1/1/2020 to 31/12/2020

This document provides information on the top five executing brokers / execution venues in terms of trading volumes where Bank Julius Baer Europe S.A. transmitted client orders received from Julius Baer Agencia de Valores S.A.U. for execution in the preceding calendar year and information on the quality of execution obtained.
