Submitting an Entry

Submitting an Entry	
Where can I submit an entry for the Julius Baer Next Generation Art Prize (the "Prize")?	You may submit an entry for the Prize via the form found at <u>https://www.juliusbaer.com/en/spotlight/next-</u> <u>generation-art-prize/</u> between 19 October and 27 November 2022. Please be informed that the webform where you submit your details is hosted on an external website outside of www.juliusbaer.com.
Must I develop a new artwork for the Prize?	To participate in the Prize, you will first be required to submit an entry via the form found at <u>https://www.juliusbaer.com/en/spotlight/next-</u> <u>generation-art-prize/</u> between 19 October and 27 November 2022. Thereafter, artists will be selected on the strength of their online portfolio before being invited to submit a concept proposal for a new artwork that they would like to develop. The jury will then select six winning submissions, and these selected artists will be invited to the final phase of the Prize where they will develop a new piece of digital art over the course of the 3-month Art x Technology Accelerator Programme, supported by mentors.
Can I submit an application on behalf of another artist?	You may submit an application on behalf of another artist, but you must obtain their permission to do so.
Can I submit an application on behalf of my collective? Are you only accepting applications from individual artists?	You may not submit an application on behalf of your collective. The Julius Baer Next Generation Art Prize is only open to individual artists. Please refer to the Terms and Conditions of the Julius Baer Next Generation Art Prize for the validity of an entry.
Can I use a pseudonym?	Yes, you may use a pseudonym in your application.
How do I know my application has been successful?	You will receive an email notifying you of your successful application.
